<b>Disclosable Pecuniary Interests</b>	
<b>1. Employment, Office, Trade, Profession or Vocation</b>

You should detail any beneficial interest in securities of a body which has to your knowledge a place of business or land in the Parish and <b>either</b> the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital, <b>or</b> one hundredth of the total issued share	none

“Securities” does not include building society accounts but includes securities of all other descriptions such as shares, debentures, stock, loan stock and units of a collective investment scheme
